PRE-QUALIFICATION OF CONTRACTORS FOR FURNISHING / RENOVATION / FIT OUT WORK OF INSTITUTE'S OFFICE PREMISES

General information for the contractors / vendors for their prequalification to carry out the above mentioned works on turnkey basis.

- 1. Intending contractors / vendors are requested to furnish details about their firm, technical experience, competence and evidence of their financial standing as per enclosed Performa for considering their names for prequalification.
- Selection of contractors / vendors will be based on the ability and competence required for good quality jobs to be performed by them. Decision of the Indian Institute of Banking & Finance regarding selection of contractors / vendors will be final and binding and no further correspondence will be entertained.
- 3. Intending contractors / vendors are requested to read carefully before filling the particulars in the Performa.
- 4. The Technical bids should be accompanied with Pay Order/Demand Draft as participation fees amounting to Rs 2000.00 (non refundable) in favour of Indian Institute of Banking and Finance payable at New Delhi.
- 5. Information / details furnished by selected party, if found to be false / incomplete at any time in future or any information effecting prequalification is willingly / unwillingly withheld, if come to the notice of the IIBF at any point of time, the company's prequalification will be cancelled immediately.
- 6. Where copies are required to be furnished, these should be self certified copies.
- The bidder should have local office in New Delhi or within NCR of Delhi including Gurugram, Faridabad, Ghaziabad and Noida.
- 8. The successful contractor will have to arrange water for the construction purpose from his own sources or as directed by MCD, at his own cost. In no case water will be supplied by the IIBF or allow to use the water available in the building. Contractors have to obtain temporary connection from the electricity Board for the renovation work, or make his own arrangement for the electricity from Generator sets, at his own cost.
- The cutoff date for calculation of past period for completion of projects shall be 30th September 2019.
- 10. All pages of the tender document i.e. Pre qualification criteria, Technical bid, Price bid should be signed and stamped by bidder.
- 11. Contractor shall appoint technically qualified full time site supervisor to monitoring the day to day progress of work at site on their own cost.

PRE QUALIFICATION CRITERIA

The mandatory criteria for the contractors should be to have local office in New Delhi or within NCR of Delhi including Gurugram, Faridabad, Ghaziabad and Noida. Other evaluating criteria are as under:

TECHNICAL CRITERIA

The bidder should have in the last Five years ending 30th September 2019 successfully completed as a prime contractor at least one similar work of value not less than 80% of estimated cost

OR two similar work each of value not less than 50%

OR three similar works each of value not less than 40% the estimated costs mentioned.

The Term similar work means Turnkey work for Interior furnishing of Training Institute / Corporate Office, commercial / Institutional building including allied civil works and services like electrical, fire fighting etc..

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 5% per annum calculated from the date of completion to last date of submission of Tender.

FINANCIAL CRITERIA

Average financial turnover of bidder during the last five years, ending 31.03.2019, should be at least 100% of the estimated cost. Company / Firm should have made profits in continuity, during last three financial years ending 31.03.2019. Audited Balance Sheet, Profit & Loss account for the last Five consecutive financial years should be submitted along with the bid.

MODE OF SUBMISSION OF TENDER:

In **First Sealed Cover** super scribed with **PART- I (Pre-Qualification Documents, Technical Bid, Earnest Money & Participation fee):** Any condition stipulated in Part-I will not be accepted.

In **Second Sealed Cover** super scribed with **PART- II (Price Bid Documents)**: It will comprise of price bid. Any condition stipulated in Part-II will not be accepted.

In **Third Sealed Cover** super scribed with Name of work, Name & Address of the Bidder will comprise of both First Sealed cover (**PART-I**) and Second Sealed Cover (**PART-II**)

OPENING OF FINANCIAL BIDS

- 1. Exact date and time shall be communicated through official E- mail address given in the bid document to the qualified bidders.
- 2. Conditional bids would be summarily rejected.
- 3. In case no bid or single bid is received, or any other reason whatsoever, IIBF may at its sole discretion cancel the whole tendering process or extend the last date and time of submission of the bid.
- 4. Any separately submitted discount letter on the financial price shall not be considered by IIBF and shall be a ground for disqualification. Evaluation of financial bid shall be considered only on the quoted price in the financial bid submitted by the bidders.
