Indian Institute of Banking & Finance invites application for the post of "Resident Engineer on retainer basis (on contract) from retired civil engineer from Banks/PSUs to supervise / co-ordinate the construction of its Institutional Building at Teynampet, Chennai.

#### **JOB PROFILE:**

The Resident Engineer is expected to undertake the following activities:

- To ensure the execution of works as per drawing and specifications.
- To ensure compliance of check list before commencement of any new works at site
- To ensure conducting all the mandatory tests for building materials at site and laboratory tests as per standard norms.
- To ensure maintenance of all registers and records as per standard norms by the contractor and architect at site and verification of the records regularly.
- To ensure for collection of required cube samples at site for all RCC works as per standard norms.
- Check measurement of steel reinforcement for all RCC works.
- To ensure smooth execution of day to day works at site.
- To ensure taking site measurements of all completed works by the contractor engineer and checking by architect as per the sequence of execution and recording measurements as per standard norms.
- Check measurements and scrutiny of running bills submitted by the contractor before forwarding the bill to IIBF for payment.
- To submit fortnight progress report to IIBF.
- To ensure bill of quantities as per execution not exceeding approved tender BOQ at every stage.
- Carrying out all instructions issued by IIBF strictly at site.

## **EXPERIENCE**

- Should have held the position of Middle Management Grade and above in Public Sector Bank (scale II and above) / Public Sector undertaking.
