The number of candidates enrolled for the DRA examination has increased by about 89% and the enrolment for DRA-Tele Callers has increased by about 38%. Overall, it has increased about 82%.

## II.5 % Non- member candidates (page 9)

The Institute offers some of the examinations to non-members to fulfil the need for knowledge of Banking & Finance by the service providers of the banking sector. The service providers of the banking sector include IT/BPO companies, NBFCs, DRAs, BC/BFs, MFIs, etc. The examinations offered only to non-members include DB&F, DRA, BC/BF and BPO/IT examinations. During the year candidates enrolled for the examinations under this category stood at **1,07,748**.
